



RoHS Declaration of Conformity

This document confirms that all products supplied by Gilgen, Müller & Weigert (GMW) GmbH & Co. KG are delivered according to the directive 2011/65 / EU2 (RoHS-II) and the extension 2015/863.

The extension 2015/863 adopted by the European Parliament to restrict the use of certain hazardous substances by Category 11 *), equipment, and a binding implementation from 21 July 2019 (RoHS III Directive), is hereby confirmed. For the purposes of this Directive, the following definitions shall apply:

As electrical and electronic equipment according to Article 3 N° 1 RoHS 2011/65 / EU are defined as follows.

- *) Devices that operate with AC power not exceeding 1 000V_{AC} or 1500V_{DC}, and
- which depend on the proper operation of electric currents or electromagnetic fields, and
 - Equipment used to generate, transmit and measure such currents and fields.

Proper operation is when at least one intended function of the device depends on electrical currents or electromagnetic fields.

GMW hereby declares that all products are RoHS compliant.

The RoHS III (EU 2015/863) Directive (Official Journal of the European Union L 174 RoHS Annex III Article 4 / paragraph 1 "exempt uses") are:

- 6a --- Lead as alloying element in steel for machining purposes and in galvanized steel with one mass fraction of not more than 0.35% lead.
- 6b --- Lead as alloying element in aluminum with a mass content of at most 0.4% lead.
- 6c --- Copper alloys containing up to 4% lead by mass.


